# Healey-Driscoll Administration Celebrates Massachusetts Agriculture Day with over \$3 Million in Grants to Support Farmers

overnor Maura Healey declared April 3, 2024, as Massachusetts Agriculture Day. As part of the celebration, Lieutenant Governor Kim Driscoll announced over \$3 million in grants to support Massachusetts farmers through programs that improve composting efforts, food safety, cranberry bog restoration, stewardship, and business planning.

Massachusetts Department of Agricultural Resources (MDAR) Commissioner Ashley Randle also announced the formation and inaugural members of the Massachusetts Agricultural Youth Council. Comprised of high school seniors, the Ag Youth Council

will cultivate and foster the next generation of leaders in the agriculture industry in Massachusetts.

Organized by the Massachusetts Farm Bureau Federation and MDAR, Massachusetts Agriculture Day at the State House celebrates the agricultural industry and gathers farmers, producers, and commodity groups from across the Commonwealth to showcase the richness and diversity of Massachusetts grown products, allowing legislators and officials the opportunity to sample locally produced food and crops and learn more about important issues directly from farmers.

"This Ag Day we're celebrating our farmers who work tirelessly throughout the year to grow and produce a diverse, healthy food supply to feed residents across Massachusetts. Last year, I witnessed the resilience of our farmers as they worked to recover from a series of devastating severe weather events," said Governor Maura Healey. "Our administration stands in support of the agricultural industry and will continue provide farms with resources to increase production and help reduce food insecurity."

"Strong, flourishing farms contribute so much more than the food that they produce. They catalyze economic benefits that go beyond the agricultural sector," said Lt. Governor Kim Driscoll. "Providing direct funding to our farmers through these programs ensures our vibrant industry continues to produce the highest quality food.

Maine has lost 1/3 of its dairy farms since 2020, and the future looks challenging. Family farms are not big money makers anywhere in New England, but Massachusetts has shown that it understands the value our farms provide in addition to food.

## Avian Influenza Update

ational headlines have focused on avian influenza over the past few months as spring migration brings more migratory birds in contact with farms. While the risk to the general population continues to be low, farmers and farmworkers—including homesteaders and backyard farmers—need to be cautious and review farm safety precautions. Now is the time to refresh your understanding of how diseases can be transmitted to your farm, your animals, and yourself and to write or update your farm biosecurity plan.

Our understanding of how this virus is changing daily (and the information contained in this article) is up-to-date as of mid-April. The Centers for Disease Control (CDC), the Animal & Plant Health Inspection Service (APHIS) of the United States Department of Agriculture (USDA), and the Food & Drug Administration (FDA) are all monitoring this situation very closely.

Avian influenza (also called "bird flu") is a type of influenza Type A that affects birds worldwide, naturally spreading among wild aquatic birds with the ability to infect domestic poultry. Outbreaks of avian influenza are not new and not unique to the United States. Various strains have been around since the late 1800s, when it was called "fowl plague".

What we are seeing in the United States right now is formally called "Highly Pathogenic Avian Influenza A (H5N1)". It first showed up in Asia in 2005 and has been moving across the world through Asia and then Europe via migrating waterfowl. It has been observed continuously in the United States year-round since 2022 with multiple outbreaks in domestic poultry, both at the backyarder and commercial scale through contact with wild birds. It has been found in poultry operations in 48 states, including two in Massachusetts this winter (Essex and Barnstable counties).

More recently, HPAI has been found in mammals world-wide, including mink, skunks, foxes, and elephant seals. While the virus is better adapted to survive in birds, it has developed to survive in mammals as well—this is where it gets to be concerning.

The current spread in dairy herds on multiple farms (currently 38) in multiple states (currently 8) is concerning at multiple levels. First identified in cattle in March, the USDA initially thought this was a spillover event where cows were infected from the wild bird population. Further investigation determined the virus was spread by asymptomatic cows bought by and shipped to other farms and from there through contact with raw milk and milking equipment. There is also evidence that beyond the spread through contact with raw milk, there are other ways it might be transmitted from cow to cow. Recent testing of grocery store milk has found fragments of DNA from HPAI in one in five of the samples tested, leading the FDA to believe dairy cow infections are more widespread than current testing shows.



A recent case of HPAI in dairy goats in Minnesota is not directly related to the dairy cow outbreak. The goats with HPAI in this instance were on a farm that had recently had an outbreak in poultry and was still under quarantine. Both the goats and the poultry had access to the same water source.

These new multiple outbreaks in mammals are concerning because of the opportunities for the virus to mutate to better adapt to survive. More chances for mutation increase the odds it will transmit more easily to humans. Previous cases of avian influenza (H5N1) in humans have primarily been in Southeast Asia, where there has been prolonged direct contact with infected poultry. HPAI A (H5N1) virus infections have been reported in more than 890 people with approximately 50% case fatality proportion since 1997, including 20 cases and 7 deaths in Hong Kong during 1997-2003 and more than 870 cases reported in 22 countries since November 2003. There is currently one human case of HPAI related to the dairy cow outbreak. The virus appears to have been transmitted from contact with raw milk directly to the eyes, with the main symptom being conjunctivitis or "pink eye".

With so much risk for farming operations, it is urgent that farmers understand the ways HPAI can get onto a farm and to take steps to reduce this risk:

- Keep an "all-in, all-out" philosophy of farm management; keep a strong separation between what is used off-farm from what is used on-farm.
- Protect poultry and livestock from coming into contact with wild or migratory birds; keep livestock away from any source of water that may have been contaminated by wild birds.
- Permit only essential workers and vehicles to enter the farm.
- Provide clean clothing and disinfection facilities for employees.
- Thoroughly clean and disinfect equipment and vehicles (including tires and undercarriage) entering and leaving the farm
- Do not loan or borrow equipment or vehicles to/from other farms.
- Take precautions when visiting other farms; if you do visit another farm or live-animal market, change footwear and clothing before working with your own livestock.
- Do not bring livestock from slaughter channels back to the farm.
- Monitor for sick animals; producers should monitor herds closely for livestock with clinical signs of disease.

"Being a fifth-generation dairy farmer, I was fortunate to have mentors to teach, guide, and empower me. The creation of the Ag Youth Council will go further - in bringing together future Massachusetts agricultural leaders to nurture their skills so that the next generation will have the tools to succeed in this everchanging field," said MDAR Commissioner Randle.

"Our administration is committed to supporting beginning farmers and providing them with resources they'll need to start and grow an agricultural business. Youth engagement and workforce development is necessary to the future of our state's agriculture industry, and I look forward to working with this first class of students."

# **Grant Funding**

MDAR is awarding over \$3 million in funding to 74 farms through the Agricultural Composting Improvement Program (ACIP),

the Agricultural Food Safety Improvement Program (AFSIP), Cranberry Bog Renovation Grant (CBRG) Program, Matching Enterprise Grants for Agriculture (MEGA) Program, and Stewardship Assistance and Restoration on APRs (SARA) Program. These programs will help to improve and strengthen their operations in the short and long term.

"On the Cape and Islands, our farmers and aquaculturists bolster our local economy and allow residents to access fresh and healthy food," said Senator Julian Cyr (D – Cape and Islands). "I am thrilled that ten farms on Cape Cod and Martha's Vineyard will receive funding through the Massachusetts Department of Agricultural Resources. These monies will ensure food safety, help renovate cranberry bogs, and support the vitality and vibrancy of our coastal agriculture industry."

The **Agricultural Composting Improvement Program (ACIP)** funds equipment and projects to improve agricultural composting practices and facilitate the use of compost as a valuable soil amendment on farms. MDAR provides technical assistance to farms conducting agricultural composting and encourages farms to utilize compost as a soil amendment or manure management tool. The **Agricultural Food Safety Improvement Program (AFSIP)** allows produce and aquaculture operations to address food safety on their farms. It enables the operations to meet buyer demands, increase local food consumption, and protect public health by reducing food safety risks. See end of article for Agricultural Food Safety Improvement Program grant recipients (Round 1 & 2) FY24. The Cranberry Bog Renovation Grant

**Program** provides reimbursement to cranberry operations that implement projects that improve both bog design and production while preventing, reducing, or eliminating negative environmental impacts that may occur from cranberry production. By funding these projects, the program enhances the cranberry industry's overall financial and environmental sustainability. The Matching Enterprise Grants for Agriculture Program assists beginning farmers who have been in business for between 1 and 10 years by providing technical assistance (including a mentorship option) and business planning assistance. Grant funds of up to \$30,000 may be available on a 1:1 matching cost reimbursement basis to assist farmers whose goal is to raise agricultural products and who are developing their farms into commercially viable operations. Funds are typically used for equipment, infrastructure, or other capital improvements to implement strategies identified during the planning process that will help their business grow. The **Stewardship Assistance and Restoration on APRs Program** helps restore active commercial farming on land that has protected through the Department's Agricultural Preservation Restriction (APR) program. Funds may be used for materials, contracted labor, or equipment rental costs to clear or reclaim inactive fields that are out of production at no fault of the current owner. Grant funds of up to \$35,000 are available on a cost reimbursement basis with a 15% match of total project costs required by the awardee. 





# American Farmland Trust: New England Soil Health Survey

Want to learn more about the health of your soil? Get **free soil health testing** on your farm by participating in our New England Soil Health Survey! Free soil testing is available through this new program from AFT New England and the USDA ARS Food Systems Research Unit. Farms in Vermont, New Hampshire, Connecticut, and Massachusetts are eligible to receive free soil health testing on up to three fields after completing this **short survey** (or scanning QR code below).

The New England Soil Health Survey will build our understanding of the impacts farmland conservation and conservation planning have on soil health in New England. Over the next two years, our goal is to reach 200 farmers and collect soil samples on 600 fields. Farmers and conservation staff can collect and submit samples independently or request support from AFT staff. To request AFT staff support, please reach out to the New England Soil Health Specialist, Kevin Antoszewski, at kantoszewski@farmland.org.

Data collected as a part of this project will be anonymized. We hope to learn about how farmers think about soil health, what practices achieve results, and how farm planning impacts soil health outcomes.



# **Deputy Director's Column**

## **Budget Process Underway, Good News For Agriculture**

n April 10, 2024, the Massachusetts House of Representatives unveiled a \$57.9 billion annual budget proposal that, among other things, includes significant investments in public transportation and early education.

The top-line number represents a 3.3% increase over last year's spending. The initial House plan comes in about \$150 million less than the Governor's FY25 budget proposal. House Ways & Means Chair Representative Aaron Michlewitz funding was cut for snow and ice removal, unrestricted general government aid, and funds for temporary staff.

The House Ways & Means budget release comes at a time of some fiscal uncertainty with state tax hauls coming in under expectations for nine consecutive months; a reality that spurred the Healey-Driscoll Administration to initiate \$375 million in mid-year emergency budget cuts for fiscal 2024. Section 9C of Chapter 29 of state law gives the Governor the authority to make unilateral budget cuts via executive branch agencies to balance the current fiscal year's budget.

The reductions did not directly impact core municipal and school aid accounts, but some reduced budget earmarks will have impacts at the local level.

To close the remaining \$625 million of the shortfall, the administration has identified certain opportunities to increase non-tax revenue.

Adding to the fiscal strain, administration officials estimate the state's emergency shelter system, which is housing a record number of homeless families and new migrants to Massachusetts, will cost nearly \$1 billion next year.

The House proposal calls for \$555 million for the MBTA—a record amount for the beleaguered public transit agency. The budget calls for \$184 million for Regional Transit Authorities in other parts of the state.

The House budget also allocates \$475 million to fully fund the Commonwealth Cares for Children grants for early education and child care. It would change the funding formula to limit how much for-profit, multi-state agencies like Bright Horizons could receive. Similar to Governor Healey's budget proposal, the House version also preserves the program providing free school meals to all Massachusetts public school students.

Despite the cautious approach being taken by the Executive branch and legislative leadership in the House and Senate, there is a silver lining in the form of continued fiscal support for the Commonwealth's robust agricultural sector.

Specifically, the House budget proposal included \$11.5 million for the Massachusetts Department of Agricultural Resources (MDAR), a slight increase from the Healey H2 proposal. The crucial Food Security Infrastructure Grant Program (FSIG) also saw a slight increase over the Governor's figure to \$25.3 million.

The FSIG Program was established to ensure that individuals and families throughout the Commonwealth have access to food, with a special focus on food that is produced locally and ensures equitable access to food.

The program also seeks to ensure that farmers, fishermen, and other local food producers are better connected to a strong, resilient food system to help mitigate future food supply and distribution disruption.


Last but certainly not least, both the H2 and House Ways & Means proposals included language that would establish a dedicated "Disaster Relief & Resiliency Fund" to better enable Massachusetts to respond quickly to natural disasters, such as the flooding experienced over the past year.

The only notable difference between the two versions is the funding source. Governor Healey's fund "would be capitalized with 10 percent of annual excess capital gains, in addition to public and private sources, federal grants, settlements, repayments, or reimbursements available for the purpose of delivering aid" while the House version included an initial \$14million investment; a meager start but an important first step no less.

While the full \$57.9 billion annual House budget proposal was formally introduced in the chamber on April 10, formal debate was scheduled to start on April 24.

The State Senate will file its own budget proposal later in the Spring, and the new fiscal year starts July 1st.

We thank the Healey-Driscoll Administration, Executive Agency officials, and House and Senate legislative leaders for their continued support of and interest in the Commonwealth's agricultural sector.
